Seller also warranties this puppy free from genetic defects (hip dsyplasia, deafness, serious eye effect, heart murmurs, liver shunts) that would prevent the puppy from being a companion animal, until the puppy reaches one year of age. Seller does not cover for luxating patellas as this is prevalent in various teacup and toy sized breeds. If this puppy is found to have a genetic defect of this kind, this must be verified by a licensed certified veterinarian. In the case of a hereditary hip deformity, a copy of written notification must come to the breeder from Orthopedic Foundation for Animals (OFA). In case of a genetic eye deformity, written notification must come to the Breeder from a Board Certified Veterinary Ophthalmologist. Due to the varying kinds of dog food on the market and the different environmental conditions the dogs come in contact with, we will not guarantee the dog unless they're given NuVet Plus daily at the manufacturer's

suggested dosage for _1_ year (length of contract). Failure to do so makes this guarantee null and void. If a "genetic disorder" is found and the puppy has been routinely given NuVet Plus daily, sellers will then replace the puppy with one of the same sex and coat color from the first available litter (puppy to be determined by the breeder/seller). The

puppy/dog shall be returned to the seller at the Buyer's expense, If buyer wants to keep the puppy, it must be neutered or spayed at buyer's expense and they will be able to purchase another puppy, of their choice, from the sellers and will be given a price discount of an amount equal to 50% of the purchase price of the original puppy.

Purchase agreement: Puppy is warrantied only for the purpose of being a pet/companion animal. Although it could be capable/suitable of performing other functions, such as show or breeding quality, no warranty is being given that purpose. If used for breeding, the sellers ask that the buyers do so responsibly, and recommend that males must be at least one year of age before used for breeding and females at least

one year of age and had at least one prior heat cycle before being bred. Breeder cannot guarantee adult size or conformation of the puppy/dog. Buyer hereby releases breeder and agrees to hold harmless for any liability, injuries or damages to persons or property caused by this puppy/dog. Buyer shall assume full responsibility for the health, temperament, and appearance of the puppy/dog upon when the puppy/dog

leaves the premise of the breeder. Also, the buyer must follow the regular vaccine, deworming, and heartworm schedule for the first year of the puppy's/dog's life. Failure to do so causes this contract to become null and void. Puppy/dog will be up to date on all vaccinations and dewormings when it leaves premise of breeder, and those records will be provided to buyer.

Third Party Sales: A third party sale of above puppy/dog will constitute this contract and its guarantees NULL and VOID.

This contract is only valid while Blue Horizon Tiny Aussies/Michelle Ringwald, the Breeder is breeding said dogs. Should Breeder cease breeding said dogs, for any reason, this contract will become null and void.
